### **ICVA ASSESSMENT GRANT – FULL APPLICATION**

The purpose of an ICVA assessment grant is to validate current, discover new, implement and support best practices in assessment in veterinary medical education. Proposals that demonstrate capacity in building knowledge of assessment practices/methods (whether pre-clinical or clinical) will be given priority. Your proposal should focus on research of performance of teaching and learning.

Total project budgets should not exceed -10,000 USD and are limited to a period of two (2) years. Further information is outlined in the attached Application form.

Suggested areas of interest/themes that may be considered are:

1. Assessing competencies across the curriculum
2. Outcome assessment
3. Assessment of clinical reasoning
4. Assessment of basic science knowledge
5. Assessment of teaching
6. Assessment of selection criteria
7. Etc.

Criteria- faculty from AVMA accredited schools.

Note that proposals will be scored and evaluated according to three overarching criteria, each with equal weight:

- Quality of the Research
- Feasibility of the Research
- Practical impact on assessment practices in veterinary medicine

#### **Timelines for the Grant Application Process**

- May 11, 2023: Grant announcement
- Letter of Intent due date: June 30, 2023
- Full proposal invitation: August 1, 2023
- Deadline Submission: October 30, 2023: 11:59pm EST
- November – December 2023: Application Review
  - Applications will be reviewed by a minimum of two (2) ICVA AVAWG members
- January 2024: Applicants notified of awards

### **Summary (200 words)**

Provide a brief summary of your proposal describing, the significance of the problem, the proposed research/assessment activity, why it is of interest, and the expected outcomes.

### **PROJECT DESCRIPTION (Maximum 3 pages single spaced)**

- The project description is to be provided as an attachment.
- Maximum 1 extra page for list of references cited.
- Indicate the name of the Principal Investigator and title of the project in the header.
- Note that applications will be assessed according to three overarching criteria:
  - Quality of the Research
  - Feasibility of the Research
  - Practical impact on assessment practices in veterinary medicine

Include the following sections:

#### **Background (max. 500 words)**

- Describe the assessment/measurement problem or topic to be researched.
- Outline the significance or importance of the work to be undertaken. What effect will it have?
- Define the problem or subject to be researched clearly and concisely.

#### **Specific Aims/Hypotheses/Research Questions (max. 150 words)**

- Define the hypotheses, theoretical framework, aims and/or research questions that will guide your work.

#### **Methods (max. 500 words)**

- Describe the methods and procedures that will be used (how the research will be done).
- Indicate plans for obtaining ethics (if required)
- Explain the choice of methodology, the data to be collected, the structure and protocol of experiments (or references to published methodologies), and the analyses to be done (including quantitative/qualitative methods).

#### **Timelines (max. 150 words)**

- Grants are for a maximum of 2 years.
- Outline milestones for the proposed research, i.e. data collection, data analysis, ethics, etc.

#### **Expected Results and Significance (max. 300 words)**

- Describe the expected results of the research.
- Include a statement of the potential significance, future use, relevance or application of the results.
- Anticipated research products (i.e. manuscripts, conference presentations, etc.)
