The Board of Directors held its summer meeting in conjunction with the AAVSB Board of Directors meeting in Kansas City on June 18-21, 2015. In Executive Session, the Board received reports from the Finance Committee, Collaboration for Veterinary Assessments Governance Committee (CVA GC), and the Stipend Working Group. The Board also adopted a new statement on diversity and inclusion:

Practice Analysis

The Board received an update on the Practice Analysis from Drs. Gary Gackstetter, NBVME and Mark Raymond, NBME. The purpose of the Practice Analysis is to ensure the NAVLE is appropriately assessing the skills and knowledge needed in practice. It is focused on the basic veterinary sciences, clinical sciences, and professional activities of entry-level veterinarians

Ms. Janine Hawley from NBME was present to provide an update on NAV-LE governance activities, new initiatives, and examination statistics. Two new research initiatives are slated for later this year. The first of those is a predictive validity study that will investigate how well scores on the NAV-LE Self-Assessments predict performance on the NAVLE.

The Board approved a presentation titled "Life of an Item." The target audience is veterinary school students who are preparing for the NAVLE. The presentation provides an overview of the NBVME, the creation of items, and NAVLE administration.

New NBVME Board Members: Drs. Susan Little and Billy Martindale



Since graduating from the College of Veterinary Medicine at Texas A&M University in 1968, Dr. Martindale has dedicated his veterinary career to private practice. Over the span of those years, his practice has included food animal, equine, game stock, and companion animal. It has been an exclusive pet animal practice for the past 15 years. With the exception of building a new facility in 1981, he has practiced at the same location in Denison, Texas as the principal owner for over 35 years. This practice is over 70 years old and received the TVMA Heritage Practice Award in 2012.

In partnership with other veterinarians, Dr. Martindale has been instrumental in the establishment of an

additional two veterinary practices in Texas. One is associated with an animal shelter and the other is an emergency animal practice.

Dr. Martindale is a founding member of the Grayson County Veterinary Association. NBVME Examination Updates

NAVLE®

The NBVME office received and processed a total of 4,496 approved candidate eligibility files for the November 16-December 12, 2015 NAVLE testing window. Candidates will be able to access their scheduling and admissions e-permits online by September 25, allowing them to make their testing appointments with Prometric.

NAVLE Self-Assessments, consisting of 200 items formatted like the actual examination, are available for purchase on the NBVME's website. The score report from the Assessment includes a NAVLE score prediction based on how well the candidate performed. There are four English forms and three French forms available. Four accredited schools now purchase vouchers allowing their senior students to complete an Assessment.

A total of 5,415 candidates took the NAVLE during the 2014-2015 testing cycle, an increase of 61 from last year. The total included 3,983 criterion candidates (senior students at accredited schools taking the examination for the first time), 818 non-criterion candidates (graduate veterinarians, repeating candidates from accredited schools, and candidates testing with accommodations) and 614 students and graduates from non-accredited schools

The 96% overall passing rate for criterion at graduation (including those who passed on their first attempt in November-December and those who failed in the fall but passed on repeating the examination in April) was one percentage point higher than last year. The mean score for the November-December criterion candidates was lower in 2014 (510) than it was for the previous two years (515 and 518).

Veterinary Educational Assessment

The Veterinary Educational Assessment (VEA) is a 200-item basic science examination used as a standardized assessment of basic science knowledge for students in veterinary school. The August 31-September 11, 2015 testing window will include administrations to 113 students at the University of Missouri, 65 students at Tuskegee University, and 16 students at St. Matthew's University. The testing windows in the 2015-2016 cycle are January 11-22, 2016 and May 9-20, 2016. Veterinary schools interested in using the VEA should contact the NBVME office.
