### **Evolution**

Punctuated equilibrium is the theory that evolution does not happen as a smooth and gradual curve, but rather moves between calm times of general stasis, followed by periods of swift and significant change. Veterinary medicine seems to be going through its own period of swift and significant change, and the NBVME is dedicated to ensuring that the NAVLE evolves in order to meet the needs of the veterinary licensing boards and of veterinary medicine as a whole.

The next two years will be a time of exciting activity for the NBVME. Some of our enhancements to the NAVLE application and score reporting system were discussed in the last issue of the National Board Report, and now I want to turn the spotlight to our upcoming practice analysis. The NAVLE is designed to assess knowledge of veterinary medicine as it relates to entry-level private clinical practice in North America. both veterinary medical knowledge and clinical practice are rapidly changing, the NBVME conducts a practice analysis on a periodic basis to ensure that the test items on the NAVLE are relevant to the tasks that practitioners perform in practice and the knowledge required for competent performance of those tasks.

In the coming months we will survey a statistically significant, representative number of veterinarians from across veterinary medicine. By replying to the survey, you'll have the opportunity to directly influence the evolution of the NAVLE. How cool is that?

## **NAVLE Practice Analysis Underway**

As noted in the last issue, the NBVME AVMA COE, the Canadian NEB, and conducts a systematic professional job (practice) analysis periodically, surveying veterinarians from across all aspects of veterinary medicine to ensure we are assessing entry level competencies on the NAVLE. The last job analysis was conducted in 2009.

While preplanning for the project began many months ago, the NBVME and our collaborators on the NAVLE, the NBME, officially launched the new professional practice analysis process with a meeting earlier this month.

Members of the NBVME Practice Analysis Subject Matter Expert Working Group met in Philadelphia, PA May 11-12. These subject matter experts will serve to review initial drafts of survey content and may be called upon for additional review. The working group is comprised of six representatives from the NBVME Examination Development Advisory Board (one for each species area), and one representative each from AAVMC,

the AAVSB.

At their first face-to-face meeting the Working Group began identifying proficiencies in the fundamental or basic veterinary sciences, clinical veterinary sciences, and professional activities of recently licensed veterinarians, as well as the knowledge, skills and abilities recarry competencies. Updates on the progress of the practice analysis will be in future issues of this newsletter.





### 2015 NAVLE Form Review

Each year, the NBVME conducts a review of draft forms of the NAVLE to be administered in the coming year. The review ensures that the forms are balanced with regard to content, and allows reviewers to evaluate the quality of the images associated with many of the items. On April 8-9, 27 veterinarians met at the offices of the National Board of Medical Examiners in Philadelphia, PA to review and approve NAVLE forms to be administered in the November-December 2015 and April 2016 testing windows. #### **NBVME** Examination Updates

#### **NAVLE®**

With all of the scores now reported, a total of 1040 candidates took the North American Veterinary Licensing Examination (NAVLE®) during the April 11-23, 2015 testing window, an increase of 12 from April 2014. The majority of scores were reported to licensing boards on May 18.

Applications for the November-December 2015 NAVLE testing window will be accepted beginning in early June, and the NBVME application receipt deadline is August 1. The 2015-2016 edition of the NAVLE Bulletin of Information for Candidates is available on the NBVME's web site (www.nbvme.org). The NAVLE fee for 2015-16 will be \$605, an increase of \$15.

All NAVLE candidates must be approved by a licensing board to take the examination. For the 2015-16 test-

ing cycle, the NBVME office will approve candidates applying through 30 states: Arizona, Colorado, Connecticut, Florida, Georgia, Hawaii, Idaho, Indiana, Iowa, Maine, Maryland, Michigan, Minnesota, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New York, North Carolina, North Dakota, Oregon, Pennsylvania, Rhode Island, South Carolina, South Dakota, Texas, Utah, Vermont, and Virginia. These candidates can complete their state NAVLE application and pay the corresponding state application fee on-line, through the NBVME's website. Information for candidates applying through other licensing boards is available in the Candidate Bulletin and on the NBVME website.

## Veterinary Educational Assessment (VEA)

The VEA is a 200-item web-based basic science examination made avail-

able to veterinary schools as a comprehensive assessment of basic science knowledge, and to provide students with experience taking a standardized multiple-choice examination similar to the NAVLE.

The VEA was administered on multiple dates in May, with St. Matthew's University School of Veterinary Medicine administering the test to 20 of their students, the University of Georgia College of Veterinary Medicine administering the test to 101 of their students, and Ross University College of Veterinary Medicine administering the test to 140 of their students. Scores will be reported by early June.

Additional information regarding the upcoming 2015-2016 VEA administration cycle will be sent to veterinary schools in early June. Schools interested in using the VEA should contact the NBVME office.
