NAVLE® Pool Review NBVME board members will join members of the

NBVME's Examination Development Advisory Board (EDAB) and some former board members in a review of several hundred items from the NAVLE item bank the day before the board meeting begins. These reviews, which are done at least once per year, ensure that items in the active item pool are suitable for continued use on NAVLE forms. Participants will work in teams, by content area, and will be assisted by editors from the NBME's test development department.

### **Strategic Planning**

The NBVME last enlisted a professional facilitator to work with the board on their Strategic Plan in May 2013, and a 2013-2015 Strategic Plan was adopted at that time.

Because of the changing needs of the profession, veterinary licensing boards, veterinary schools, students and other stakeholders, the NBVME will gather in early December in Chicago, Illinois with a professional facilitator to once again review and update their Strategic Plan. In preparation for this meeting, the facilitator conducted one on one interviews with meeting participants, and a survey was sent out to stakeholders in October seeking feedback to be used to guide the strategic plan update. Many of you have provided input to this process through your survey responses and we thank you for doing so.

Finalizing the NBVME Strategic Plan will be on the Board's agenda at the January meeting in San Diego, California.

### **Fall NAVLE Item Review Meeting**

Twenty-four of the 28 2014 NAVLE item writers met at the NBME office in Philadelphia, Pennsylvania November 10-11 to review NAVLE items written and submitted earlier this year. Nearly 800 new items were approved for addition to the NAVLE item bank.

Each form of the NAVLE includes 300 scored items and 60 pretest items, and all new items are pretested before they are used as scored items. Pretesting ensures that items that count toward a candidate's score have acceptable performance statistics. New items approved at the November 2014 review meeting will appear for the first time as pretest items on examination forms developed for use during the 2015-2016 NAVLE testing cycle. Most NAVLE item writers are appointed by the members of the NBVME's Examination Development Advisory Board, according to the main content areas of the examination. Work is now underway to finalize the list of item writers for 2015.

### **NBVME** Examination Updates

#### NAVLE®

The November-December 2014 testing window for the North American Veterinary Licensing Examination (NAVLE) runs from Monday, November 17 through Saturday, December 13. The NBVME office processed and submitted 4,430 candidate eligibility files for this testing window; 57 more than in November-December 2013.

Applications for the April 13-25, 2015 testing window will be available beginning in early December, and the NBVME application receipt deadline for new candidates is January 3. Scores from the November-December testing window will be reported in mid-January. Candidates who do not pass the November-December 2014 NAVLE will be able to reapply for the April 2015 testing window by the repeater application receipt deadline of February 15.

#### **Qualifying Examination**

The Qualifying Examination (QE) is a 200-item basic science examination used as a standardized assessment of basic science knowledge for students in veterinary school. The 2014-2015 QE Bulletin of Information for Candidates is available on the NBVME's web site. Copies of the 2013-2014 QE Technical Report were mailed in August. On September 4 and 5, the University of Missouri administered the web-based OE to 108 of their students. Iowa State University will be administering the test to 143 of their students in January. Veterinary schools interested in using the QE should contact the NBVME office.

#### **Species Specific Examinations**

Since 1997, the NBVME has offered species specific examinations in companion animal and equine medicine to licensing boards. There are two 100item forms for each examination. The paper and pencil examinations are used by boards in disciplinary cases and for other purposes. The present test forms were last updated in early 2014. Licensing boards interested in reviewing or administrating the updated species specific examinations should contact the NBVME office.
