VISIT TO BISMARCK

The NBVME's Executive Committee met in Bismarck on October 23-24. This marked the fourth time that the Executive Committee has made the trip to North Dakota.

On October 23, Secretary-Treasurer Dr. Ben Franklin and I visited six area financial institutions where the NBVME has funds on deposit, to meet staff and update account information.

The full Executive Committee, including Dr. Franklin and Drs. Dennis Feinberg (Chair), Linda Blythe (Chair-Elect) and Meg Glattly (Past Chair), met that evening and the following morning. Topics discussed included a Request for Proposal for a new NAVLE job analysis, renewal of the NBVME's contract with the National Board of Medical Examiners for development of the NAVLE, the date and location for the summer 2009 meeting (July 25 in San Diego), arrangements for a temporary NAVLE test site in Perth, Western Australia to accommodate candidates from Murdoch University, and the status of a NAVLE irregular behavior case. The Executive Committee also met with the NBVME's auditor.

NBVME staff rarely get to meet board members, item writers, licensing board representatives, and other people with whom we interact on a daily basis via telephone and e-mail. That makes a visit like this especially welcome. The Executive Committee members enjoy the opportunity to visit the office, meet the staff, and gain an appreciation of what Bismarck, North Dakota is like. We think it's a great place to live and work!

Board Visits Are Underway

At its July 2008 meeting, the NBVME approved a plan to improve outreach to licensing boards, which are the NBVME's primary clients. The plan calls for teams of two NBVME members to visit individual state licensing boards to conduct a "directed dialogue" with board members and staff.

The goal is to complete about 20 visits in the first vear, with the rest of the boards to be visited in the following two years. Drs. Dennis Feinberg and Mike Thomas worked with an outside facilitator, Mr. Michael Barrett, to develop a computer presentation that outlines how the NBVME is structured and what it does. During the visits, the NBVME members seek feedback from licensing

boards on the services received from the NBVME at the present time, and ideas for additional services to be provided in the future.

To date, Drs. Feinberg and Thomas have made visits to four boards: New Jersey, North Carolina, Maine, and Massachusetts. Drs. Ben Franklin and Rick Tubbs have visited the Missouri board, and Dr. Linda Blythe and for-

QE ITEM **REVIEW**

The Qualifying Examination (QE) is a web-based 300-item basic science examination developed by the NBVME for use in the AAVSB's Program for the Assessment of Veterinary Education Equivalence (PAVE). The QE is also used by four accredited veterinary schools as an outside assessment of basic science knowledge.

Each fall, the QE item writers meet in Philadelphia to review newly-written items and approve them for addition to the item bank. On October 1-2, 10 of this year's 11 item writers participated in the review. The 2008 QE item writers included Drs. Kevin Anderson, Gainesville, FL (anatomy); Pete Bill, West Lafayette, IN (pharmacology); Paul Davenport, Gainesville, FL (physiology); Ron Green, Dallas, TX (principles of radiology); Mary Hondalus, Athens, GA (bacteriology); Ron Johnson, Guelph, ON (pharmacology); Sanjay Kapil, Stillwater, OK (virology and immunology); Susan Little, Stillwater, OK (parasitology); Abdelfattah Nour, West Lafayette, IN (physiology); Jon Patterson, East Lansing, MI (pathology); and Beth Spangler, Auburn, AL (clinical pathology).

QE item writers for 2009 are now being named. New item writers will meet at the NBME on February 24 for an item writing workshop, and will join returning QE item writers the next day to review the three forms of the examination to be administered in the 2009-2010 testing cycle.

AAVSB Meeting Report

This year's annual meeting of the American Association of Veterinary State Boards (AAVSB) was held in Newport Beach, California on September 18-20. Four NBVME members (Drs. Dennis Feinberg, Mike Thomas, Meg Glattly, and Lila Miller) attended the meeting, along with four NBVME staff members. Drs. Boyce, Feinberg, and Thomas gave a joint presentation to the AAVSB Delegate Assembly, providing an update on NBVME activities and summarizing goals and objectives for licensing board visits.

The AAVSB meeting offers an excellent opportunity for NBVME members and staff to interact with members and staff from individual licensing boards. This year's meeting included an interesting presentation on examination security from Jennifer Semko, an attorney from Washington DC, and an update on the Foresight Report from AAVMC Executive Director Dr. Marguerite Pappaioanou.

After the meeting, the NBVME staff had the opportunity to visit with former NBVME member Dr. Nancy Collins at her home in Alta Loma, California. Dr. Collins is an equine practitioner, and was the recipient of the 2008 NBVME Award.

NAVLE® Item Review



NAVLE Score Portal

The NAVLE score portal, which allows certain NAVLE candidates to access their pass/fail status online, will be activated again in January, following the November-December 2008 testing window. Candidates who applied through one of the 12 licensing boards for which the NBVME office handles approvals (CO, FL, ME, MD, MI, NE, NH, NJ, NY, PA, UT, and VA) will be able to access the score portal through the NBVME's web site, on the same date scores are released to licensing boards. To retrieve their results, candidates enter their NAVID number (which they received at the time they applied for the examination) and their date of birth. These candidates will also receive printed copies of their score reports through the mail. All other NAVLE candidates will continue to receive their score reports through the licensing board that approved them to take the examination.
